→ **Academic School Year:** With the exception of August, which will be prorated, all monthly rates have been set according to the total number of school days offered. **All Extended Day Plans begin in September.** And in the case of abbreviated days of attendance, such as Winter Break, monthly fees remain the same.

→ **Summer Program:** ED Plans are only available if attending the entire month of June and/or July, with the same exact schedule. Drop-in Care is billed at 10 cents per minute.
